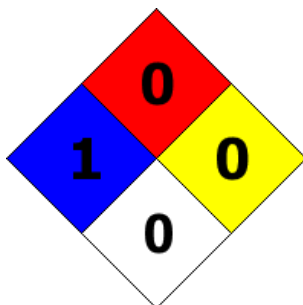

### SECTION 4: First aid measures

#### Description of first aid measures

##### After inhalation:

### Environmental precautions:

### Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Always obey local regulations. Wear protective eyewear, gloves, and clothing. Refer to Section 8.
